

# YOUTH CLIMBING ENROLLMENT FORM

# GARDEN STATE ROCKS

• The September 2021-June 2022 year has 5 sessions (the 6<sup>th</sup> session – July and August – will be covered in a future memo given out during session 5). Each session has 8 (or 9) weeks. The tuition covers the whole session. **PAYMENT IS DUE DURING THE LAST WEEK OF ANY CURRENT SESSION FOR THE NEXT SESSION** – you are paying in advance. Under no circumstances is tuition pro-rated, unless the student joins after the start of a session.

• **ENROLLMENT IN ANY SESSION DOES NOT AUTOMATICALLY CARRY OVER TO A NEW SESSION.** Although a student needs to re-register for each session, those already enrolled are given preference and can register before classes are opened for new students. If you chose not to enroll your child for any session, regardless of the reason, GSR cannot hold the slot for your child. However, upon re-enrollment, there is no re-registration fee, unless the annual registration fee is due.

• **MAKE UP CLASSES** are provided for **NOTIFIED ABSENCES ONLY**, which means **GSR** must be notified at least **1 HOUR IN ADVANCE** of the missed class. These excused absences are kept on record and make up lessons are scheduled on **OTHER** appropriate days and times by contacting the gym. If available times provided by **GSR** are not convenient, **GSR** is not obligated to provide alternative times. **MAKE UPS** are provided as courtesy and **ONLY CURRENTLY ENROLLED STUDENTS WITH UP-TO-DATE TUITION ARE ELIGIBLE.** A child's regular class cannot be used as a makeup – in other words, make up lessons cannot be taken instead of enrollment and payment of tuition. **NO CREDIT OR REFUNDS ARE GIVEN.** Make ups will be carried from session to session until the end of session 6 (August 2022) at which time they will expire.

• If **GSR** is **CLOSED** due to inclement weather or other unforeseen events, a special make up day and time will be provided; or families will have the option of taking a makeup within the regular schedule. Tuition credit **IS NOT GIVEN** for these closings.

• All participants are required to pay a \$40.00 registration fee. It is payable prior to the first class and renewable every 12 months. Our insurance company requires the parents of all enrollees to read and sign the **WAIVER** and **RELEASE** form below:

*GSR is bound to inform all participants and their parents or guardians that, as with any sport or physical activity, participation in climbing carries with it certain risks including catastrophic injury, paralysis, and even death, as well as other damages and losses. I agree that GSR, along with the employees, agents, officers and directors of this organization shall not be liable for any losses or damages occurring as a result of my child's participation.*

*For any participant who is not 18 years old: As legal parent or guardian of this participant, I hereby verify by my signature below that I fully understand and accept the waiver and release conditions above and the GSR policies for permitting my child to participate in GSR activities.*
